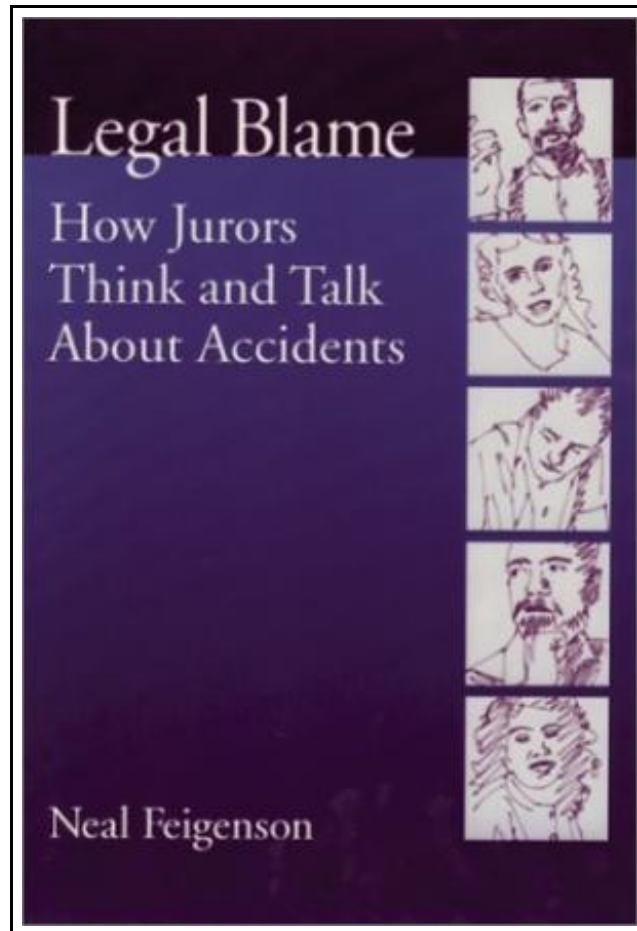

Contrary to common stereotypes about jurors, jurors integrate their thoughts and feelings to reach decisions that are usually correct enough by legal standards, although not always for what the law would consider the right reasons. This text provides a nuanced appreciation of the civil jury, with examples and in-depth analysis of how jurors help make tort law.
